# Country Garden Achieved Contracted Sales of Approximately RMB33.65 billion for the First Half of 2013

(3 July 2013 – Hong Kong) Country Garden Holdings Company Limited ("Country Garden" or the "Group", SEHK stock code: 2007), one of the leading integrated property developers in China, announced that the Group achieved contracted sales of approximately RMB33.65 billion for the first half of 2013, with contracted sales GFA of approximately 5.07 million sq.m..

The Group continues to put intense efforts in improving the residents' quality of living by enhancing various aspects such as community facilities, environment and services. Such moves further enhance the attractiveness of our products as evidenced by the customers' enthusiastic responses. In the first half of 2013, Country Garden Hill Lake Bay<sup>2</sup> (Guangzhou Nansha) recorded contracted sales of approximately RMB1.71 billion. In addition, Country Garden Grand Garden<sup>3</sup> (Dongguan Tangxia) and Country Garden - Galaxy Palace (Shenyang) recorded contracted sales of approximately RMB1.66 billion and RMB1.63 billion respectively.

From the middle to the end of June, the Group launched two new projects in Jiangsu Province, namely Yixing Country Garden in Wuxi City and Rudong Country Garden in Nantong City. The products were well received by the market with total transactions of approximately RMB1.04 billion achieved up to the end of June. Due to the timing of the debut launch of these two projects, majority of these transactions were not yet reflected in the contracted sales for June.

The Group will continue to launch a number of new projects as well as to make further launches of existing projects in the second half of 2013. The Group is confident of achieving the full-year contracted sales target.
