(2) Pursuant to the terms of the share option scheme of the issuer adopted on 20 March 2017, the board of directors of the issuer has resolved in the board meeting of the issuer held on 22 March 2017 that, despite the resignation of Mr. Su Rubo effective from 1 April 2017, the 186,342 share options granted to him on 16 March 2016 would remain exercisable on a date which is no earlier than 5 years from their date of grant.
