### UNAUDITED OPERATING FIGURES

The board of directors (the “**Board**”) of Country Garden Holdings Company Limited (the “**Company**”) is pleased to announce that as of 19 September 2016, the Company and its subsidiaries (collectively, the “**Group**”), together with its joint ventures and associates, achieved contracted sales of approximately RMB200.00 billion and contracted sales GFA of approximately 24.83 million square meters, representing an increase of approximately 164% and 112% as compared with the achieved contracted sales and contracted sales GFA for the corresponding period in 2015, respectively. This is the first time that the Group achieved contracted sales up to approximately RMB200.00 billion, which have set a new sales record for the Group.

The satisfactory operational results are primarily due to, among others, the favourable market environment, enhancement in the strategic layout of the projects, products that satisfy the clients’ wants and needs in different markets at different stages of development throughout the country, reasonable marketing plan, and sound execution of the partnership scheme.
