Property development related business

The Group has entered into a cooperation agreement with Shanwei Municipal Land Development & Reserve Centre in May 2007, to co-develop a site in the Northeast Shore of Pinging Lake of Dongchongpinhuan of Shanwei Municipality [東涌片環品清湖東北岸] with a land area of approximately 3.0 million sq.m.

Country Garden was listed on the Main Board of the Hong Kong Stock Exchange on 20 April 2007 making it the top mainland property developer listed in Hong Kong in terms of market capitalization. The listing not only provides the Group with additional funding to sustain future growth, it also marks the Group's first step into the international capital market.

Land acquisition

- From 2 April 2007 to 30 June 2007, the Group has acquired new sites with an additional GFA of 10.46 million sq. m. adding to its land bank. The new sites are located in Shenyang in Liaoning Province; Shaoguan, Jiangmen and Shanwei in Guangdong Province; Changsha and Zhangjiajie in Hunan Province; and Chaohu in Anhui Province. The land acquisition strengthened the Group's presence outside Guangdong Province.
- As of 30 June 2007, the Group has a land bank with an attributable GFA of 29.58 million sq. m. Between 1-15 July 2007, the Group acquired another four new sites in Wuhan of Hubei Province, Manzhouli of Inner Mongolia, Haicheng of Liaoning Province and Chaohu of Anhui Province, contributing an additional aggregate GFA of 7.07 million sq.m. to the land bank. Total consideration of the four new sites is RMB755 million. Human resources development
- In preparation for the rapid business development post listing, the Group has recruited 639 new employees with bachelor's degree or above from the beginning of this year to 30 June 2007. Among the new recruits, 43 are master degree holders and one with a doctoral degree.

New hotel opening

- Yangdong Country Garden Hotel was officially opened in May 2007. The hotel is located within Yangdong Country Garden with five star standard. It has 342 guest rooms in total.
- Currently, the Group has 5 five-star standard hotels in operation with a total of 1,331 rooms; and another 6 fivestar standard hotels under construction.
