### GRANT OF SHARE OPTIONS

This announcement is made by Country Garden Holdings Company Limited (the “**Company**”) pursuant to Rule 17.06A of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board of directors (the “**Board**”) of the Company hereby announces that on 5 December 2019, the Company has offered to grant to 3 executive directors of the Company, namely Mr. MO Bin (“**Mr. MO**”), Mr. YANG Zhicheng (“**Mr. YANG**”) and Mr. SONG Jun (“**Mr. SONG**”) (collectively, the “**Grantees**”) of 9,825,134 share options (“**Mr. MO’s Share Options**”), 432,848 share options (“**Mr. YANG’s Share Options**”) and 206,292 share options (“**Mr. SONG’s Share Options**”) respectively, with a total of 10,464,274 share options (collectively, the “**Share Options**”, each a “**Share Option**”) under the share option scheme adopted by the Company on 18 May 2017 (the “**Share Option Scheme**”) which, subject to the acceptance of the Share Options by the Grantees, will enable the Grantees, upon full exercise of all such Share Options, to subscribe respectively for 9,825,134 shares, 432,848 shares and 206,292 shares with an aggregate of 10,464,274 new shares of HK\$0.1 each (the “**Share(s)**”) in the share capital of the Company for the subscription price per Share Option set out below (all subject to adjustments under the terms of the Share Option Scheme in accordance with Rule 17.03(13) of the Listing Rules), such Shares respectively representing approximately 0.0450%, 0.0020% and 0.0009% and in aggregate approximately 0.0479% of the issued share capital of the Company as at the date of this announcement. The 6,517,965 share options granted by the Company to Mr. MO on 18 May 2018 has been cancelled with effect from 5 December 2019.
