The board of directors (the “**Board**”) of the Company hereby announces that on 30 March 2020, the Company has offered to grant to an executive director of the Company, namely Mr. MO Bin (“**Mr. MO**”), of 18,587,411 share options (“**Share Options**”) under the share option scheme adopted by the Company on 18 May 2017 (the “**Share Option Scheme**”) which, subject to the acceptance of the Share Options by Mr. MO, will enable Mr. MO, upon full exercise of all the Share Options, to subscribe for 18,587,411 new shares of HK\$0.1 each (the “**Share(s)**”) in the share capital of the Company for the subscription price per Share Option set out below (all subject to adjustments under the terms of the Share Option Scheme in accordance with Rule 17.03(13) of the Listing Rules), the Shares representing approximately 0.0851% of the issued share capital of the Company as at the date of this announcement.
